There are no royalties or commercial use clauses to complicate things. In almost every case, you will not need to choose anything other than the AFL and in the common case you need not do anything to denote this choice of license. Many people and organizations are more familiar with the BSD license, and we encourage those people to use Dojo under those terms if it suits them better.
