

# End-of-Sale and End-of-Life Announcement for the Cisco NCS 1000 XR 6.0.0 and 6.0.1 Software Operating System

Cisco announces the end-of-sale and end-of-life dates for the Cisco NCS 1000 XR 6.0.0 and 6.0.1 Software Operating System. The last day to order the affected product(s) is December 19, 2017.
